TO WILLIAM P. HANCOCK, JR., CHIEF OF POLICE IN OGUNQUIT VILLAGE CORPORATION,  
IN THE TOWN OF WELLS, COUNTY OF YORK AND STATE OF MAINE.

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the Inhabitants of the Ogunquit Village Corporation, qualified by law to vote in Corporation affairs, to meet in the S. Judson Dunaway Community Center, School Street, Ogunquit, Maine, on the twenty-sixth (26th) day of August 1975 A.D. at Seven Thirty (7:30) O'Clock in the evening then and there to act on the following Articles:

ARTICLE 1: To choose a Moderator to preside at said meeting.

ARTICLE 2: To see if the Corporation will vote to approve the Ogunquit Village Corporation Comprehensive Plan Land Use Growth and Development Policies, dated July 1975 as proposed by Edward C. Jordan Co., Inc. and approved by the Ogunquit Planning Board. *yes*

ARTICLE 3: To see if the Corporation will vote to approve the Zoning Ordinance, Village of Ogunquit in the Town of Wells, Maine dated 1975, as approved by the Ogunquit Planning Board and to repeal the present Zoning Ordinance of the Ogunquit Village Corporation in the Town of Wells, Maine, adopted September 23, 1959, and its amendments adopted April 4, 1960, April 5, 1971, March 27, 1972 and March 26, 1973. *yes*

ARTICLE 4: To see if the Corporation will vote to approve the request of the Ogunquit Fire Company as follows: to remove the old municipal building located on Cottage Street, including leveling of foundation, removal of sewer, electrical, telephone connections grading of land; the vacant property then to be used for parking and/or future expansion of the Fire Station, at the discretion of the Ogunquit Fire Company. *yes*

ARTICLE 5: To see if the Corporation will vote to approve the sale of the old municipal building by sealed bids, with the reservation that any or all bids may be rejected at the discretion of the Board of Overseers. Purchaser shall be responsible for the removal of the building as per specifications written by the Town Manager. *yes*

ARTICLE 6: To transact such other business as may legally come before this meeting.
