

WARRANT RETURN FOR THE ANNUAL TOWN MEETING
OF THE TOWN OF OGUNQUIT

April 5, 7, 1986

The Annual Town Meeting was called to order by Town Clerk Madeline D. Brown with the reading of the call, return and First Article. Meeting convened at 9:00 A.M.

Sharon O'Brien, Violet Rand, Norma Turnbull, Anne Marie Johnson served as Ballot Clerks. Counters were Robert O'Brien and the aforementioned Clerks.

Article 1 through 12 were done by secret ballot. A total of 198 citizens voted at the April 5 Town Meeting. Polls closed at 6:00 P.M.

ARTICLE 1: Barbara Lord was elected Moderator and sworn in by the Town Clerk at 9:05 A.M.
