

On July 16, 1980, the Town of Ogunquit voted to form a transit district for the purpose of providing transportation service within the municipality in accordance with Title 30, M.R.S.A. sec. 4971, et seq.

On July 24, 1980, the Board of Selectmen of the Town of Ogunquit appointed citizens to the transit district board in compliance with the above mentioned statute.

Enclosed herewith is a Certificate of Organization for the Ogunquit Transit District. You may also be interested to know that the Transit District has contracted with the Ogunquit Chamber of Commerce to provide transportation through the use of two leased trolley-type vehicles. The route is within Ogunquit and the fare established is 25¢.
