

WARRANT RETURN FOR SPECIAL TOWN MEETING

TOWN OF OGUNQUIT

DECEMBER 28, 1982

The Special Town Meeting was called to order by the Town Clerk, Madeline Brown, reading the call, return and first Article. Meeting started at 7:35 p.m. (Over 400 people attended.)

Barbara Lord, Robert O'Brien, Sharon O'Brien, Mary McClelland, Kevin O'Neil and Lee Shibles were Ballot Clerks.

ARTICLE 1. Attorney David Ott was elected Moderator.

Motion made to move Article 6 through 13 first. It was moved and seconded. Motion carried by a show of hands. 268 yes. 18 no.

Motion was made to go to secret ballot on all Articles. It was moved and seconded. Motion carried by a show of hands. 301 yes. 33 no.

ARTICLE 6. Passed as read by a secret Ballot. 268 yes. 131 no.

A motion was made to withdraw secret ballot on Article 7 through 13. A motion was made and seconded by a show of hands. The motion carried. 188 yes. 24 no.

Sheila Fine made a motion to declare Article 6 void. Vote count was off by two.

Moderator declared it a valid vote. Moderator gave it to the house. House passed moderator's decision by a show of hands. 35 yes. 266 no. Motion carried.
