Re: Allocation of FEMA Reimbursement

We continue to work with representatives of the Federal Emergency Management Agency (FEMA) and the Maine Emergency Management Agency (MEMA) to secure reimbursement funds resulting from damages sustained during the spring 2018 storm events (FEMA-ME-DR-4367). The Town sustained considerable damage during these storms, with the repairs being done on an ongoing basis.

To date FEMA/MEMA have obligated eleven (11) of the projects totaling \$462,516.76. The allocation of funding for these projects is as follows:

Federal Share	\$346,887.57
State Share	\$69,377.51
<u>Local Share</u>	<u>\$46,251.68</u>
Total	\$462,516.76

The total Federal and State Reimbursement that the Town is eligible to receive for the obligated projects to date amounts to \$416,265.08. The Town is in receipt of its second reimbursement check in the amount of \$ 116,393.91 bringing the total received to date to \$241,580.27. These funds are considered special revenues and will be allocated to the Special Projects Revenue Accounts as follows:
