

WARRANT FOR SPECIAL CORPORATION MEETING JANUARY 20, 1969

To CECIL F. PERKINS, a Police Officer in the Ogunquit Village Corporation in the Town of Wells, County of York and State of Maine:

GREETINGS:

In the name of the State of Maine you are hereby required to notify and warn the Inhabitants of the Ogunquit Village Corporation, qualified by law to vote in Corporation affairs, to meet in Firemen's Hall in said Corporation on Monday, the twentieth day of January 1969, A.D. at seven-thirty o'clock in the evening, then and there to act on the following articles:

- ARTICLE I: To choose a moderator to preside at said meeting.
- ARTICLE II: To see if the Corporation will vote to appropriate from money unappropriated at the Annual Corporation meeting the sum of EIGHT HUNDRED FIFTY FOUR DOLLARS AND NINETY ONE CENTS (\$854.91) to cover an overdraft in the Summer Roads Account, of that amount.
- ARTICLE III: To see if the Corporation will vote to transfer from the unappropriated surplus account, the sum of TWO THOUSAND SEVEN HUNDRED DOLLARS and THIRTY CENTS (\$2,700.30) to the sidewalk account to cover an overdraft in that account.
- ARTICLE IV: To see if the Corporation will vote to transfer from the unappropriated surplus account, the sum of FOUR HUNDRED SIXTY FOUR DOLLARS and TEN CENTS (\$464.10) to the Insurance account to cover an overdraft in that account.
- ARTICLE V: To see if the Corporation will vote to transfer from the unappropriated surplus account, the sum of TWO THOUSAND THREE HUNDRED SIXTY THREE and THIRTY SIX CENTS (\$2,363.36) to the DUMP account to cover an overdraft in that account.
- ARTICLE VI: To transact such other business as may legally come before this meeting.
